The Certified Arborist recognition is given by the ISA to those who (1) meet the eligibility requirement for admission to the exam (including 3 years experience in Arboriculture or 2 years with a two or four-year degree in a related field), (2) successful completion of the exam and (3) maintain the necessary number of continuing education units to recertify after three years.

Any qualified professional wishing to take the **exam on March 26** must complete an official Arborist Certification Exam Application form and submit the form with their testing fee directly to ISA, by **March 8, 2012**. You can download the exam application at:

Students must register separately through the ISA to be eligible to take the exam on March 26. **Fees for the exam must be paid Directly to ISA.** ISA must receive the exam application and applicable fees no later than 12 business days before the exam. Please be sure to have your application to the ISA office by **March 8, 2012**. Exam applications are available on the IAA and ISA websites. IAA office will e-mail you the link to the exam application with your registration confirmation letter and we will hand them out the first night of class.
