THE CERTIFIED ARBORIST RECOGNITION IS GIVEN BY THE ISA TO THOSE WHO (1) MEET THE ELIGIBILITY REQUIREMENT FOR ADMISSION TO THE EXAM (INCLUDING 3 YEARS EXPERIENCE IN ARBORICULTURE OR 2 YEARS EXPERIENCE WITH A TWO OR FOUR YEAR DEGREE IN A RELATED FIELD), (2) SUCCESSFUL COMPLETION OF THE EXAM AND (3) MAINTAIN THE NECESSARY NUMBER OF CONTINUING EDUCATION UNITS TO RE-CERTIFY AFTER THREE YEARS.
